# ICOS-ERIC Application Process — The Road to ERIC

- First ISIC meeting in June 2010 Helsinki
- Approval of Lol for signatures in ISIC May 2011 Brussels
- ISIC agreement on Statutes and other documents
  - ISIC May 2013 Rome
- Informal ERIC application to the Commission (Step 1)
  - Verification of compliance with the ERIC Regulation
  - FI, BE, CZ, FR, DE, IE, IT, NO, PL, ES, SE, CH, NL, UK, (DK).
  - June 2013
- Feedback from the Commission
  - Request for modifications
  - December 2013/January 2014
- ISIC agreement on modified Statutes and other documents
  - March 2014

  - April 2014
- Request letters received

# **ICOS-ERIC Application Process – III**

#### Next Steps

- Decision of the Finnish Government to sign the application
  - Decision expected by mid-March 2015
  - Application sent via Finnish EU Perm. Rep. to the Commission
- Approval of the <u>Finnish Parliament</u>
  - Agreement between Ministries on a simplified process and confirmed by the Commission
  - Member States shall take such measures as are appropriate to ensure the effective application of this Regulation
    - Appropriate provisions Article 18 of the ERIC Regulation
  - Government proposal to Parliament (May/June 2015)
    - Consists of two articles:
      - Recognition of ICOS ERIC as a legal entity in Finland
      - Implementation of the VAT excemption in Finland
  - Decision of the Parliament (June 2015)




